

# Admittance Application Spirit is Calling 3 Year Trance Channelling Healing Program

# **Program Description:**

This program is a sanctuary for a new step in spiritual awareness and growth. You will become proficient in navigating between the spiritual and physical worlds with awareness and control. In the process of your training, you will gain clarity about who and what you are as a soul, more fully live your life, bring more joy to your relationship with your physical body, and strengthen your relationship with yourself and the Supreme Being.

The curriculum focuses on training you, the eternal spirit, to safely leave your physical body, entrust the healing and functioning of your body to another spirit, and to return safely to your body. During this training, you will also learn how to facilitate this process for others in a group setting as a healing-line control, run a healing clinic, and give clairvoyant communication about the mechanics of trance mediumship.

### **Admission Requirements:**

- 1) Satisfactory completion of a clairvoyant training program.
- 2) Some post-graduate training in spiritual healing.
- 3) An "energy-check" (short clairvoyant reading) with the Spirit is Calling staff on your ability to use clairvoyant tools, trance medium levels, and desire to attend the program.
- 4) Ministerial entitlement in good standing at either Spirit is Calling or another religious organization.
